- 3. Tenderer are requested to quote their prices on a firm & fixed basis only for the complete supply of equipments. Tender of the firms received with prices quoted on variable basis shall be rejected straight away.
- 4. Quotations qualified by such vague and indefinite expressions such as "subject to prior confirmation", "subject to immediate acceptance" etc will be treated as vague offers and rejected accordingly.
- 5. Tenderers are requestd to enclose a copy of their valid certificate of PAN No., TAN No, and Service Tax No. with technical bid.
