Eligibility Criteria

Bidder must be a registered supplier of furniture with the appropriate authorities. For this purpose, the bidder should enclosed the relevant documents in support of it.

Method of Submission

Bidders must submit their sealed offer with Price bid (Quotation), which must be ink-signed, and sent either by Post/Courier or Personally handed over at the Institute on or before last date of submission. The sealed bid which is not submitted in proper manner and stipulated period, shall be liable to be rejected and Purchaser shall not take any responsibility whatsoever in this regard.

Bid Security

Bid security should be 5% of the total bid-value. It will be accepted in the form of an account payee Demand Draft or Banker's Cheque in favour of Incharge, Ayurveda Central Research Institute, Jaipur with the bid offer.

The bid security will be forfeited, if the bidder, after being issued with order, failed to comply the order within stipulated period. The bid security of all the unsuccessful bidders will be returned after finalization of bid process. The bid security of successful bidder shall be returned after the physical verification of furniture supplied by the authorities at the destination indicated in the order. No interest will however be paid on bid security.

Cancellation of bid

The Officer Incharge of the Institute has reserves the right to accept or reject the bid partially or in totally without assigning any reason.







Annexure-II

Terms and Conditions

1. Supply shall be made at Bhilwara district F.O.R. as per list of addresses (enclosed).
2. The Furniture shall be supplied with-in 15 days (Inclusive of the Road Transportation time) after receiving the Purchase Order positively. No extension of time limit is permissible except for the reasons and conditions beyond control (to be justified to the entire satisfaction of the Incharge. ACRI, Jaipur)
3. Purchase Order should be executed in Full. No part supply will be accepted and the entire Lot of supply will be rejected without any financial liability on the part of Institute.
4. All kinds of breakage / Pilferage etc. occurred to the Furniture during the course of supply and transit have to borne by you.
5. Bid Security will be refunded after satisfactory supply of the Furniture in the Institute. Necessary TDS as per rules shall be deducted from the Bill wherever required.
6. Recycled Furniture will not be accepted in any case. In that condition the Tender shall be rejected and treated as NULL and VOID, with forfeiture of Bid security.
7. Furniture should be supplied of the same Make, Brand etc. as quoted.
8. The items of furniture supplied must be well packed at your cost. The packing should be in such a safe manner. as these items are to be delivered finally at District Bhilwara (Rajasthan).
9. Bidder has to enclosed with bid, copy of PAN card / Income tax and Sales tax clearance certificate duly self attested.
10. Institute is not abide to purchase the goods even if the rates are minimum.

14. Any disputes, if arises, will be setteled under Jaipur Jurisdiction as per laws.


