**1) TENDER VALIDITY**

Tender shall remain open for acceptance for a period of 1year from the date of opening of Tender. Tenders received for shorter validity will be rejected.

**2) TENDERER'S ELIGIBILITY AND QUALIFICATIONS**

Sealed quotations are invited from eligible Publishers/Booksellers/Distributors having at least three years experience of supplying Medical /Scientific/Technical Journals (Indian & Foreign) to Medical College/ Educational Institution libraries.

**3) EARNEST MONEY DEPOSIT**

Tenderer shall furnish along with their tender, a Earnest Money deposit for Rs.10,000/- (interest free) in the form of crossed Demand draft in favour of "Director, All India Institute of Ayurveda, payable at New Delhi". Failure of the tenderer to furnish required earnest money deposit along with their tender will result in rejection of their tender.

The EMD of unsuccessful bidders will be returned as promptly as possible after the expiry of the period of tender validity without interest. Advance stamp receipt for refund of EMD should be enclosed with the tender documents.

**4) PRICE SCHEDULE AND PAYMENT TERMS**

- a) Tenderers should quote rate of discount (in percentage) offered on publishers printed rate for journals in Annexure-III. **If quotation is not made for a particular item of journal the same should be filled up with the words " Not Quoted ". Soft copy of the quotations should also b e enclosed in the form of CD/ DVD in a sealed cover.** The Director is not bound to accept the lowest bid or any tender and also reserves the right of rejecting all or any of the tender without assigning any reason.
- b) The current bank exchange rate (TT selling rate) on the date of purchase order for Medical Journals shall be used for conversion of foreign currencies supported by a certificate issued by a scheduled bank and countersigned by the supplier. All payments will be made in Indian rupees only.
- c) **100% advance payment can be made on production of bank guarantee for an equivalent amount by the supplier. The Bank guarantee can be released in parts depending on the progress made in the supply of journals.**
- d) Proof of remittance of subscription to the publishers (both Indian and Foreign) has to be produced to the Director, All India Institute of Ayurveda (AIIA) within 30 days of making advance payment.
- e) The tenderers should give an undertaking that only Medical/ Ayurveda Journals (Indian & Foreign) of latest edition have been quoted and will be supplied and the prices have been charged correctly and in accordance with the latest publishers catalogue/invoice or importer/distributors invoice.

**5) TERMS OF DELIVERY**

All the Journals should be delivered free of cost at the Library of All India Institute of Ayurveda, Gautampuri, Sarita Vihar, New Delhi-110076.

## 6) DELIVERY PERIOD

- a. Medical/ Ayurveda journals should be supplied as soon as published or becomes available in the market but not later than 15 days after their availability in the market.
- b. The delivery shall be through Registered/Book Post/Parcel/Courier/in person on the risk and responsibility of the firm. No postage, Insurance or any other charges whatsoever extra shall be paid.
- c. Only original Journals will be accepted and no duplicate/defective/ photocopies of these shall be entertained. If any such instance comes to the notice, the same shall be returned on risk and cost of the firm.
- d. The firm will supply (i) Original Electronic CD of Journals as received by them from Publishers free of cost; (ii) Subscription numbers for all the journals to facilitate the user free line services against print Journals.

## 7) PENALTY CLAUSE

- a. **For delays:-** If the supplier fails to supply the journals as per purchase order within the time period specified in the contract, the purchaser shall deduct from contract price/EMD/Bank guarantee a sum equivalent to 0.5% of the price of delayed items for each week of delay or part thereof until actual delivery up to a maximum of 10(ten) percent. Once the maximum is reached, the purchaser may consider termination of the contract.
- b. **Termination on default:-** The purchaser may, without prejudice to any other remedy on breach of contract, by written notice of default sent to the supplier, terminate the contract in whole or part if the supplier fails to deliver any or all publications ordered to him within the time period specified in the contract, or if the supplier fails to perform other obligation(s) under the contract. In the event of the termination of the contract by All India Institute of Ayurveda in whole or in part, the Institute may procure, upon such terms and in such manner as it deems appropriate the undelivered Medical Journals & periodicals and the supplier shall be liable to pay for any excess cost for such purchases. However, the supplier shall continue performance of the contract to the extent not terminated.
- c. **Force majeure:-** The supplier shall not be liable for (a) and (b) above, if its delay in performance or other failure to perform its obligations under the contract is the result of an event of force majeure (Means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable). Such events may include, but not restricted to, acts of the purchaser either in its sovereign or contractual capacity, wars or revolution, fires, floods, epidemics, quarantine restrictions and freight embargo.
