2. The tender(s) must be submitted in a sealed cover, addressed not in personal name, but be submitted by designation to the Research Officer In charge, Ayurveda Research Institute for Mother and Child Health Care , Poojappura , Thiruvananthapuram, by hand /Courier/Regd.Post/A.D
3. The cover shall bear the address of tenderer and shall be super scribed with the words. **“Tender for Supply of Hospital furniture/Laboratory equipments /Gyanec instrument”**separately.
