1.0 INTRODUCTION

The Central Council for Research in Ayurvedic Sciences (CCRAS) is an autonomous body of the Department of AYUSH (Ayurveda, Yoga & Naturopathy, Unani, Siddha and Homeopathy), Ministry of Ayush, Government of India. It is an apex body in India for the formulation, coordination, development and promotion of research on scientific lines in Ayurveda and Sowa-Rigpa system of medicine. The site contains details about Ayurveda and Sowa-Rigpa systems. The activities, job opportunities and achievements of the Council in different aspects of these streams of traditional medicines are available here.

1.1 OVERVIEW

The Council has a website under the name of http://www.ccras.nic.in keeping in view of technological enhancements in web technology the Department needs to redesign its website so as to develop a dynamic database driven website with Web 2.0 features and web guidelines issued by the National Informatics Centre (NIC) and adopted by Department of Admin Reforms & Public Grievances. 2.0 USABILITY FEATURES OF WEBSITE

Home page:

- Homepage should be attractive and well-constructed, so that it makes a good first impression to all who visit the site.
- Tag line should increase user's understanding of the site.
