It is an apex body in India for the formulation, co-ordination, development and promotion of research on scientific lines in Ayurveda and Sowa-Rigpa systems of medicine. The Council has been executing its research programmes with a network of 30 peripheral Institutes/centres/units across the country with the headquarters office responsible for control, monitoring and supervision. The broad areas of Research comprise Medicinal Plant Research (Medico-ethno Botanical survey, cultivation, Pharmacognosy), Drug standardization Research; Pharmacology Research (Pre clinical Safety/Toxicity and Biological Activity Studies); Clinical Research and Literary Research & Documentation. The extension activities include Tribal Health Care Research, Health Care Services, Information, Education and Communication (IEC) etc. The Central Council for Research in Ayurvedic Sciences (CCRAS) invites nominations for the Best Research Paper Award every year. - v) The nominee should be referred by at least 3 authorities including Head of any research/teaching/training organization of Ayurveda/Allied Sciences with Ayurvedic wing/ Ayurvedic PG Institution/ Director Ayurveda/AYUSH of State/Central Government/ UT Administration.
- vi) The Nominee should not be related either by blood, marriage or adoption to the person making the nomination provided that such a person has not played any direct part in the nominee's work.
