Sub:- Furnishing of preference of posting under Rotational Transfer –reg.

Sir/Madam,

I am directed to refer this Council's communication No. 12-33/2020-CCRAS/Rectt/5362 dated 06.01.2021 circulating therewith the Rotational Transfer Policy as issued by Ministry of AYUSH vide their letter No. L-19013/24/2020-AS dated 05.11.2020 vide which the Institutes were requested to furnish the data in respect of Officers/Officials completing 07 years of residency period at one station. The requisite data has since been received from peripheral Institutes and compiled unit wise at CCRAS Hqrs Office.

2. As per the recommendations of Rotational Transfer Committee in its meeting held on 24.01.2022 and in term of clause 18.3 of Rotational Transfer Policy, the preference choice from the Officials concerned needs to be furnished. The Officials concerned may furnish 03 preferences for posting with reasons within the available vacancies within 15 days of the notification of vacancies. Therefore, the officer/officials who have completed prescribed period of 07 years at one station should furnish 03 preferences for posting as per the vacancies notified and uploaded on the website. The copy of details of such vacancies is also enclosed herewith for information and action.



3. The peripheral Institutes are further requested to check on the website, the details of officers furnished by them who have completed prescribe period of 07 years or more is correctly uploaded in respect of their unit. In case the name of any officer who has completed prescribed period at one station is not figuring the same may be sent to Hqrs office immediately preferably within 07 days for inclusion along-with choices for preference posting with reasons within the available vacancies. Failing to furnish the preference choice by any officer, it would be presumed that he does not have any choice preference and decision to post him under rotational transfer would be taken as per the vacancies available on meeting the preference choice of other officers.

This issues with the approval of Director General Incharge.
